



## HUMANE SOCIETY OF THE OHIO VALLEY MEMBERSHIP DRIVE



### **Did You Know:**

• HSOV was incorporated in 1888, is the first animal shelter organized in Ohio, and is the only animal shelter currently serving Washington County.

• HSOV provides care and shelter for up to 1,200 to 1,500 animals each year. Almost all are returned to owners or placed in "forever homes" through adoption and rescue programs.

• HSOV is a "No-Kill Shelter" which means that euthanasia is never used to solve overcrowding or to make space in the shelter for other animals. Euthanasia is resorted to only when it is the only humane option for a sick or injured animal. Only 47% of animal shelters in Ohio are No-Kill.

• HSOV's operating budget in 2021-22 is \$ 570,000. Service contracts with the City of Marietta and Washington County yield slightly more than \$ 78,000 or represent less than 14% of annual income. Other revenue sources include adoption fees, fundraising events, membership fees, private donations, interest and dividends from investments, and bequests.

• Our largest fundraising event each year is Fur Ball. This event was cancelled in 2020 and operated on a limited scale in 2021 due to the pandemic. The combined loss in fundraising revenues for these two years exceeded \$ 48,000. • Consistent with national trends, HSOV's intake declined radically with the onset of Covid-19 as citizens stayed close to home and devoted care and attention to pets. Adoption and foster rates also paralleled national trends as animal lovers used more time at home to adopt and introduce new companions into households. Now, as we move away from Covid our animal population is back to pre-pandemic levels. In addition, a new factor, inflation, is driving up all costs, especially for veterinary care as many stray and surrendered animals arrive at the shelter with urgent veterinary care needs. At current utilization rates, we anticipate veterinary care costs to exceed budget by nearly \$ 25,000 in the current year.
